Buurtzorg Nederland, in The Netherlands has setup this research group in association with Praan Group, The Netherlands at Banasthali Vidyapith. It promotes research in Integrative Self Management inspired by Buurtzorg and concept of Swadharm in Bharatiya Prabandhan (Indian Management).

Banasthali has been contributing to women's education for more than eight decades. To take further strides in innovation & entrepreneurship, it has now Atal Incubation Centre supported by Atal Innovation Mission, NITI Aayog. This is one of its kind Incubation Centre supporting women led startups. Banasthali also has a Centre for Research in MSME & Promotion of Entrepreneurship in Women (CRMPEW) and an E-Cell supported by State Bank of India dedicated to cause of women entrepreneurship.

### **Conference Theme**

Integrating Simplification Theory (IST) is a dynamic approach for organizing and entrepreneurial thinking and fits within Organization Designs. It is a process of engaging in simplicity and refraining from complexity to avoid organization disintegration. Disintegration can be of any kind of wastage of resources or time (artha), misalignment between personal and organizational motives (kama) and misalignment between personal and organizational values (dharma). Globally, there have been some good examples of both old and new institutions running with such a paradigm. A good reference is Buurtzorg Nederland – a community care nursing organization in the Netherlands with 14000 employees with no managers and serving 70,000 clients every year in a self-managed way.

A sustainable foundation for IST can be found in an Integrative Paradigm which gets its manifestations in an Integrative Worldview. Such a Worldview does not discard any perspective or purpose but it hosts many perspectives and purposes holistically. Technological advancements especially digitalization and robotizing are shaping up the organizational processes and purposes. Technology may thus evoke or accelerate the experience of VUCA (Volatility, Uncertainty, Complexity, and Ambiguity) which subsequently creates fear and distrust.

A way to develop acceptable and fear-free innovative Organization Designs is by establishing harmony between Technology and Humaneness. An innovative lens to understand VUCA can be found in Ancient Wisdom of Kaliyug. Intelligence is a core phenomenon of social sciences but now we live in an era where Human (Natural) Intelligence needs to be integrated with the Artificial Intelligence. We can envision such integration in Functional Systems (Marketing, HR, Finance) in organizations, Organizational Systems (Bureaucracies or Self-Management).

Many management scholars are seeking and building new Organization Designs. The conference aims to build bridges with initiatives such as Teal Organizations, Mindful Organizations, Organizations with a Purpose and Meaning. Apart from that, every culture has lot of cultural artefacts that embodies the elements mentioned in the theme and subthemes of this conference. Further to foster the integrative research approach, the conference aims to bring the host country wisdom. In the present edition, contributions from paradigms of traditional ways of management including Bharatiya Prabandhan (Indian Management) are encouraged.
